Vinyl Emulsion Primer is a sealer especially designed to lay down the nap of drywall. It has excellent enamel hold-out properties that prevent variation of sheen in the finish coats.

- **1. RECOMMENDED USES:** Use on new sheetrock or drywall. Also may be used on plaster, concrete, brick, wood, or previously painted porous surfaces.
- **2. LIMITATIONS:** Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For interior use only. Apply only when the atmospheric temperature and surface temperature will remain above 50°F, and not in foggy or rainy weather.
